The Airport Authority voted to give this potential buyer and anyone else who wants to bid two options to ease the potential buyer's concerns about his money sitting in escrow and the new airport falling through, explained Airport Authority Bill Johnston, citing the sales process of land at Fort McPherson as part of those concerns.

Box A, Johnston said, "the amount goes into an escrow account, there's one closing and he's entitled to the land at the end, when the airport closes, During that time we can use the money to buy out the existing leases and to move current tenants over.

The difference in A and B. Airport Authority Chairman Dick Morrow explained, is when the owner wants to take control of the property.

Brock asked Monday night that it be clarified as to what's going in there. He also questioned the \$15 million price, as "outrageous amount for that property," saying "it's worth about \$6 million. and for that much (\$15 million) he's going to put in whatever he wants."

Morrow said "it is put out for bid, and it's all subject to our approval what goes in there," with Airport Authority member

The \$15 million includes the land and the buildings in the business park, Morrow said, and explained "we have to buy out the aviation business buildings and facilitate moving those businesses onto the new airport."

Brock, a Hillandale resident, said he was concerned about "the property values if he puts an amusement park in there."

The board voted unanimously, including Brock, to put it out for bid, with a \$15 million minimum. Sealed bids will be opened by the Airport Authority legal committee, which will sift through them and make a recommendation to the full board.
