Man gets life sentence for murder at Stockbridge motel

A Jonesboro man will spend the rest of his life in prison for killing his ex-girlfriend inside a Henry County motel.

A Henry County jury convicted Tory Leroy Jones Sr., 47, of malice murder, felony murder, aggravated assault, possession of a firearm during the commission of a felony and possession of a firearm by a convicted felon.

The jury found Tory Leroy Jones Sr. shot Elimisha Gates in the back of the head while she was asleep on Aug. 22, 2016.

Henry County Superior Court Judge John A. "Trea" Pipkin III sentenced Jones to life without parole plus 10 years.

The jury found Jones shot Elimisha Gates in the back of the head while she was asleep on Aug. 22, 2016, at the Express Inn and Suites on Georgia Highway 138 in Stockbridge. Jones later fled to Alabama. A

maintenance man found Gates, 43, of Atlanta, dead inside the motel room the next day.

"This was a brutal and senseless killing," Henry County District Attorney Darius Pattillo, "I am pleased this heartless and dangerous individual will never walk the streets of Henry County or anywhere else again."

Judge orders paper ballot contingency plan for Georgia

ATLANTA — If Georgia election officials fail to meet the tight timeline they've set to implement an entirely new voting system, they'll have to quickly pivot to hand-marked paper ballots for the March presidential primaries.

That's according to a Thursday ruling by U.S. District Judge Amy Totenberg.

certified a new vot-

ing system and said

it will be in place by

perger's office, Meritt Beaver, acknowledged during a court hearing last month that the implementation schedule is "tight."

The state's \$106 million contract with Denver-based Dominion Voting Systems includes new touchscreen voting machines that print a paper record with a code that's read by a scanner.

Raffensperger said in an emailed statement Thursday that his office is "already moving full steam ahead" to implement the new system.

2002. Election integrity advocates and individual voters sued in 2017 alleging that the touchscreen voting are unsecure and vulnerable to hacking.

They had asked Totenberg to order an immediate switch to hand-marked paper ballots, noting that special and municipal elections are scheduled before March. The judge declined, citing concerns about the state's capacity to make an interim switch to hand-marked paper ballots while also working to implement a new system.
