Following the collision, Beam said, Martin's car, a black 2000 Gran Prix, caught fire in the engine area. The trooper and Griffin Code Enforcement helped extinguish the fire, according to various accounts, with the trooper or deputies removing the occupants, either four or five of them, from the car. According to the

State Patrol, the occupants were trapped inside and were removed by the trooper, with four being injured. Two were airlifted and two were taken by ground to the hospital, all with serious injuries, according to the State

Beam said there were five occupants in the car, with three airlifted to Atlanta area hospitals and Martin being transported by ambulance to the Spalding Regional Hospital.

The Georgia State Patrol is investigating the accident and charges are pending against Martin, the sheriff said.

According to fire department call logs, the Engine 1 from Spalding County Fire Department was dispatched at 10:34 a.m., and arrived at 10:40 a.m., Monday, to an accident with injuries on West Ellis Road at Henry Jackson Road. They remained on scene until 11:58 a.m.

program to South Atlanta Youth Association, which had shadowed the county officials this past season. Of the nine-member board, six were present at the time of the vote, two voted in favor, three abstained and the acting chairman did not vote.

At Monday's county commission meeting, South Atlanta Youth Association President Donald Driver wanted to know why his group was told it had to go back before the Advisory Commission.

"Our board followed the instructions. and shadowed the county staff for the past year," Driver said, "but we was told we have to go back before the Parks and Recreation board. We want to know why?'

The county commissioners discussed the matter at their meeting Monday while making plans for a workshop. Commissioner Raymond Ray said there were concerns "based on the number of votes, the number of abstentions, as well as someone from out of county offering to do it. We have to be especially careful about that, after the last time."

He was referring to Anthony Ramos and Good Samaritans Community Development, that had undisclosed financial backers for the summer and after school program, which the backers closed down

Luckie said the authority shows pros-

pects a variety of information pertaining

due to declining participation.

That too was a concern shared by County Commissioner Gwen Flowers-Taylor, who said, "they had a vote and allowed them (South Atlanta Youth Association) to run it. Why jump in there and add someone else, especially someone from out of

She also asked if the other group would have to shadow county staff for a year first, and cited concerns that the county would have to then fund the program next season. Football is the only sport the county funds and operates, with next season to be first run by an association, like all of the

County Commissioner Bart Miller, who ran the football program when he was a county employee, said Monday, "maybe we need to listen to both of them. We've got to come up with money if they pull out."

South Atlanta Youth Association is scheduled to provide an update to the Parks and Recreation Advisory Commission tonight as well.

There also were some questions last month about the association having enough funding and enough start-up funds to make it work and cover costs, including equipment repair and replacement prior to registration fees coming in. There was about a \$12,500 difference in what Driver said the budget was and what county staff said the costs would be.

"The message to prospects is: If you can't find it in Griffin, you can find it in a

30-mile radius," he said. The development authority lost some projects over the past couple of years, Luckie said, because prospects thought the community wasn't close enough to I-75, I-85 or Port of Savannah. Another reason, he added, was that some communities are willing to give away everything, whereas he believes that when the
